NOMINATIONS TO BOARDS, COMMITTEES, AND COMMISSIONS (VARIOUS) (GREAT-2(36))

The Committee is in receipt of correspondence dated June 17, 2022, from the Mayor, transmitting the following:

1. A proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE MAUI PLANNING COMMISSION FOR THE COUNTY OF MAUI," with a completed application form for the nominee. The proposed resolution's purpose is to approve or disapprove the Mayor's nomination of Mark Henry Deakos to the Maui Planning Commission, for a term expiring on March 31, 2027.

2. A proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE POLICE COMMISSION FOR THE COUNTY OF MAUI," with a completed application form for the nominee. The proposed resolution's purpose is to approve or disapprove the Mayor's nomination of Arragon Kekoawiwaole Mowat to the Police Commission, for a term expiring on March 31, 2027.
3. A proposed resolution, entitled "APPOINTMENT OF A MEMBER TO THE PUBLIC WORKS COMMISSION FOR THE COUNTY OF MAUI," with a completed application form for the nominee. The proposed resolution's purpose is to approve or disapprove the Mayor's nomination of Nathan Kalani Ignacio to the Public Works Commission, for a term expiring on March 31, 2027.

The Committee must approve or disapprove the nominations listed above by August 16, 2022, or the nominations will be deemed approved. The Committee may consider whether to recommend adoption of any or all of the proposed resolutions, with or without revisions. The Committee may also consider other related action.
