The Committee is in receipt of County Communication 20-140, from Councilmember Shane M. Sinenci relating to the matter of an axis deer management plan.

The Committee may receive updates from the Department of Housing and Human Concerns, the Office of the Mayor, the State Department of Land and Natural Resources, and Lokahi Pacific related to potential solutions for axis deer management in Maui County and discuss related matters. No legislative action will be taken.
