COMPREHENSIVE AFFORDABLE HOUSING PLAN: EXPANDING AFFORDABLE HOUSING FUNDING (AH-14(7))

The Committee is in receipt of the following:

1. Correspondence dated November 23, 2021, from the Committee Chair, transmitting informational documents relating to expanding affordable housing funding.
2. Correspondence dated August 10, 2022, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 3.35.040, MAUI COUNTY CODE, RELATING TO THE ALLOWABLE USES OF THE AFFORDABLE HOUSING FUND." The purpose of the proposed bill is to expand the allowable uses of the Affordable Housing Fund.

The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider whether to recommend the filing of the proposed bill and other related action.
